I. The name of the Association shall be "LEO MUTHU EDUCATIONAL TRUST" and the Registered Office of the Educational Trust shall be situated at No.33/1 Bazullah Road, T. Nagar, Madras 600 017.

II. Its objects are:

1. To open, run and continue educational and vocational schools, or colleges or Technical Institutions or Polytechnics for the said purpose.
2. To engage teachers, professors, instructors and experts of School moral character and conduct able to impart efficiently and economically up-to-date instructions to pupils and students.
3. To establish, maintain and run a boarding and Lodging house and residential institutions for the students/and those connected with the institution.
4. To public or arrange for the publication of books, journals, periodical etc. and other allied subjects in Tamil English and Hindi and such other languages, to achieve and furtherance of the subjects stated above.
- 4a. To acquire lands by purchase or lease in the name of Trust for the construction of buildings for running School and other educational purposes.
5. To build or acquire buildings or lands for Kalyana Mandapam and to give them at a nominal rent for celebration of marriages and other functions to deserving persons.
6. To build or acquire buildings for running hospitals nursing home or clinic and to render free medical aid to the poor or on minimum charges.




7. To construct or maintain orphanages, Dharmasalas and institutions and for relief of human suffering and eradication of poverty.



I. Its objects are:

"PATRONS" shall be persons who found one or more cottages or make permanent arrangements to pay of the association Rs.100/- annually or make a lump sum contribution of not less than Rs.2,000/- to its permanent funds.

"LIFE MEMBERS" shall be those who contribute Rs.1,000/- or more to the permanent funds of the Association.

"ORDINARY MEMBERS" shall be those who pay an annual subscriptions of not less than Rs.12/- to the Association.

"HONORARY MEMBERS" shall be those who are admitted as such in recognition of service rendered to this cause.

The Association shall have power to admit or reject any application for membership without assigning any reasons. No person shall be admitted unless by a resolution passed by a majority of 75% of the members on the roll.

III. The Affairs of the Trust shall be conducted by a Managing Committee consisting of not less than seven members.

If any temporary vacancy occurs among the Committee Members it shall be filled by the Committee members themselves from among the members of the Association and the person so appointed shall retain office during the remaining period of such vacancy.

- IV. The Managing Committee may from time to time borrow from members or other persons or Associations on mortgage or charge of all or any part of the property of the Trust for the promotion of the objects of the Trust any such sum or sums or money secure repayments of such sums in such manner and upon such terms and conditions as they may think fit.
- V. The President shall manage the Trust subject to the General Supervision of the Board. He shall take possession and be in charge of all properties of the Trust receive donations grants etc., and give receipts and discharges, appoint, suspend fine and dismiss servants of the Trust pay salaries defray all charges, grant leave to the members of the Staff, keep regular accounts receipts and disbursement and maintain vouchers.

XII. SPECIAL RESOLUTION:

a) A special resolution is a resolution passed by a Majority of 3/4 (three-fourth) of the members of the Society entitled to vote as are present in person at the General Body meeting of which a notice of not less than 21 days shall be given specifying intention to propose the resolution as a special resolution has been duly give.

b) Special resolution is required for the following subjects:

i) To amend the objects relating to memorandum of Association for the objects stated in Sec.12 of the Act.

ii) To amend the bye laws.

iii) To change the names of Association.

iv) To dissolve the Association.

- c) The date of Annual general Body Meeting will be held (15th June) within a period of 6 months after the expiration of the financial year to Audit Report etc. giving 21 days clear notice.
- d) The Managing Committee shall meet once in a month giving 7 days notice.
- e) Emergency Meeting of the Committee may be convened by the President giving three days notice.
- f) Extraordinary General Body. This may be called at any time by the Committee on receipt of requisition from two third of the total members.
- g) The Quorum for the meeting of Managing Committee will be one-fourth of the strength and that of General Body will be three-fourth of the total members.
- h) The meeting for want of Quorum. All meetings shall be adjourned for want of Quorum atleast 3 days. The business of original Meeting shall be transacted irrespective of the quorum.


XIII FINANCE: The main source of income of the Trust is from members. Donations can be collected if specifically authorised by the Managing Committee.

- a) All the money received should be deposited in a Nationalised Bank and such account should be operated jointly by the President and Treasurer.
- b) An imprest cash of Rs.250/- to meet the urgent expenditure is allowed.

XIV. If the Society is dissolved the properties will be transferred to such other Trust having the same object.

XV. DUTIES AND POWERS:

- a) PRESIDENT: The President shall be the head of the Trust and his advice shall be taken in all the matters

- b) SECRETARY: The Secretary shall be the Executive Authority to perform such duties as are necessary for achieving the objects of the Trust. He shall
- i) Conduct the correspondence.

  - iv) He is authorised to sue and be sued on behalf the Trust.
